

FUND BALANCES**DIA**

The School Board will return to the town any unassigned general fund balance at fiscal year-end, such monies to be used to offset the next fiscal year's tax rate.

Additionally, any fund balance shall only be used or returned in accordance with applicable New Hampshire law and/or Governmental Standards Board Statement 54 (GASB 54).
